

Award for Young Artist

藝術新秀獎

目的

支持及鼓勵年青和新進藝術工作者，獎項以藝術界別分類，包括藝術評論、舞蹈、戲劇、電影、媒體藝術、文學藝術、音樂、視覺藝術及戲曲。

獎項

- 每個藝術界別設有一個獎項，範圍可包括編劇、編舞、導演、作曲、表演者、從事藝術創作者、舞台設計者、舞台技術人員、藝術研究與評論等。
- 每位得獎者除獲頒獎座外，亦可獲港幣 22,000 元作為進行藝術活動 / 創作或進修計劃。計劃須於一年內完成，然後向本局提交報告。

候選人資格

- 須以個人名義競逐獎項，並持有香港身份證；年齡為 35 歲或以下 (以截止日期計)；
- 須由一位人士提名 (提名人可以個人或團體名義進行提名)；
- 須從事相關藝術界別工作最少一年；
- 須提供在 2010/11 年度^(註⁸)的有關藝術工作成績、表現及專業工作記錄^(註⁹)；
(候選人須於 2010/11 年度內曾在本港或海內外進行藝術工作 / 活動。文學藝術界別候選人所提交的 2010/11 年度出版著作 / 作品，必須為該年度首次發表。)
- 候選人不可接受多於一個藝術界別的提名；
- 凡曾獲藝發局頒發「藝術新進獎」、「傑出青年藝術獎」、「藝術新秀獎」的人士均不可再次競逐該藝術界別的獎項，但可接受其他藝術界別及其他獎項的提名；
- 候選人可以同時接受提名競逐「年度最佳藝術家獎」^(註¹⁰)。

評選準則

- 以候選人在 2010/11 年度完成的藝術工作成績、表現及專業工作記錄為主；
- 作品的創新性和候選人的創造力表現；
- 積極投身藝術工作，具有成為藝壇生力軍的素質。

Objective

The award aims to support and encourage young and emerging arts practitioners. It is divided into a number of categories covering various art forms including arts criticism, dance, drama, film, media arts, literary arts, music, visual arts and xiqu.

Types of Awards

- One award will be presented to a practitioner of each art form, such as a scriptwriter, choreographer, director, composer, performer, creative artist, stage designer, stage technician, arts researcher and critic.
- Besides a trophy, each winner will receive a cash award of HK\$22,000 to fund an arts project or further studies. The winners will be required to submit a report concerning how they used the cash award to the ADC within one year of the completion of their projects or studies.

Eligibility

- Nominees should be nominated in their personal capacity and possess a Hong Kong Identity Card. They should be 35 years of age or below on the date of the nomination submission deadline;
- Nominees should be nominated by one proposer (individuals or on behalf of an organisation);
- Nominees must possess at least one year of relevant working experience;
- Details should be submitted about the nominee's relevant work results, performance and professional working records for 2010/11 ^(Note⁸ & Note⁹) ;
(Nominees should have conducted artistic work or activities in Hong Kong or overseas during 2010/11. In the case of nominees in the literary arts category, publications/works submitted should have first been published during 2010/11.)
- Each nominee may be nominated for an award in one art form only;
- Previous recipients of the ADC's Rising Artist Award, Award for Outstanding Young Artist and Award for Young Artist may not compete in the same art form category for which they previously received an award, but they may be nominated in a different category; and
- Nominees may be nominated for the Award for Best Artist concurrently ^(Note¹⁰) .

Assessment Criteria

Nominees must demonstrate:

- Active dedication to the arts, substantiated by relevant work results, performance and professional working records for 2010/11;
- Evidence of the innovation and creativity of their artistic works; and
- Qualities that will enable them to become a new force in the arts sector.

Note⁸ The period covered is from 1 September 2010 to 31 August 2011, both dates inclusive.

Note⁹ Besides the nomination form, the following information about the nominee should be provided to facilitate assessment:

Written illustrations or artwork; Performance records (on CD, DVD or VCD); Images of artwork (DVD/ VCD); Published works; and relevant reviews, press clippings, certificates or letters concerning awards received and event publicity materials (Please refer to the nomination form for details).

Note¹⁰ Nominees who wish to compete for the Award for Best Artist concurrently should refer to the relevant information in these Guidelines and submit the appropriate form.
